The City of Napoleon will be beginning a street tree trimming project on Thursday, December 7, 2017, and will continue for the next 1-2 weeks. All Seasons Tree Care has been contracted by the City to trim all street-side City owned trees (with the exception of a few private trees that interfere with public clearances) on the streets listed below. The streets to be trimmed are as follows:

750 & 756 W. Washington Street

714 Monroe Street

225 Fillmore Street

818 & 822 Hobson Street

Maple Street - Depot Street to E. Clinton Street

Vocke Street - Fillmore Street to Dead End

E. Clinton Street - Monroe Street to Hobson Street

E. Riverview Avenue - N. Perry Street to Commerce Drive

Lamar Lane - E. Riverview Avenue to Cul-de-sac

Stout Street - E. Riverview Avenue to E. Main Street

Wayne Street - E. Riverview Avenue to E. Main Street (Dead end towards the park)

Jefferson Street - E. Washington Street to E. Front Street

Hobson Street - E. Riverview Avenue to E. Front Street

Monroe Street - E. Riverview Avenue to E. Front Street

E. Washington Street - E. Riverview Avenue to Dead End

E. Main Street - Monroe Street to Stout Street

E. Front Street - N. Perry Street to Jefferson Street


Additional Trimming if this list is completed will include areas south of the river.

This is a routine maintenance trim to remove crowded, poorly attached, diseased, dead branches and debris, and to obtain eight (8) foot clearance over sidewalks and fourteen (14) foot clearance over driveways and streets. Some trees may need more work than others and will be done for the safety of the community and its infrastructure as well as the health and future of the urban forest. **We will not be removing any trees in this contract.**

Please take care when driving in these neighborhoods as there may be times where debris and equipment may limit access or partially obstruct the roadway. If you live in these neighborhoods, please try to park on adjacent side streets or in driveways to avoid falling branches and to allow access for the contractor vehicles.
