Dear Taxpayer :

As your employer does NOT withhold local income tax and/or you are self-employed, printed on the back side is your estimate payment form. Please use this form when making your estimate payments in 2019.

**Chapter 194.07(B)(1) of the Codified Ordinances states:**

**“Every taxpayer shall make a declaration of estimated taxes for the current taxable year, on the form prescribed by the Tax Administrator, if the amount payable as estimated taxes is at least two hundred dollars.”**

*Failure to make such payments as outlined above may result in the following, per Chapter 194.10(C)(2) of the Codified Ordinances:*

**“With respect to unpaid income tax and unpaid estimated income tax, a penalty equal to fifteen percent of the amount not timely paid shall be imposed.”**

In short, this means if estimated taxes are not paid during the year as required, a fifteen percent (15%) penalty may be added at the time of income tax filing.
