Only State of Ohio Department of Transportation Pre-Qualified Contractors are eligible to submit bids for this project. Pre-qualification Status must be in force at the time of bid, at the time of award, and through the life of the construction contract.


Federal Prevailing Wage Rates are applicable to the contract. Bidders must comply with the most current Federal Prevailing Wage Rates for Heavy and Highway Construction Project (Decision Number OH20100002). The Wage Determination in effect at contract execution must be paid to all laborers and mechanics working on the project for the contractor and all subcontractors.

There is a DBE Goal on this project of 5%. This is the percent of the awarded contractor's bid which must be subcontracted to Certified ODOT DBE firms. The percentage goal may be met if the awarded contractor is DBE Certified. **A DBE Utilization Plan must be submitted per PN 013** of ODOT's LPA Template.
