FEDERAL PREVAILING WAGE RATES ARE APPLICABLE TO THE CONTRACT. ANY PROPOSED EQUAL FOR A STANDARD SHALL BE SUBMITTED TO THE ENGINEER NOT LATER THAN TEN (10) DAYS PRIOR TO THE BID OPENING. IF NO ADDENDUM IS ISSUED ACCEPTING THE PROPOSED EQUAL AS AN APPROVED EQUAL, THE PROPOSED EQUAL SHALL BE CONSIDERED REJECTED.

ALL BIDDERS MUST SUBMIT A DBE UTILIZATION PLAN AT THE TIME OF THE BID. ANY BIDS RECEIVED WITHOUT ELECTRONIC SUBMISSION OF THE DBE UTILIZATION PLAN AT OR BEFORE BID TIME, WILL BE DEEMED UNRESPONSIVE. THE DBE UTILIZATION PLAN MUST BE FILLED OUT COMPLETELY AND SUBMITTED PRIOR TO BID OPENING.
